The Pledge of Allegiance was recited.

The minutes of November 20<sup>th</sup>, 2012 were reviewed. A motion was made by Bormann and seconded by Bueltel to approve the minutes. All voted in favor. None voted against. The motion was carried.

The Truth in Taxation hearing was opened to receive public input on the budget and proposed taxes. There were no attendants for the hearing. A motion was made by Bormann and seconded by Eilers to close the hearing. All voted in favor. None voted against. The motion was carried.

The Planning Commission recommended approval of a special use permit for Allyson Yackley to operate a massage therapy business in the house she rents with the condition that it will be valid for one year upon which it will be reviewed. A motion was made by Hanson and seconded by Bormann to approve the special use permit as recommended by the Planning Commission with the condition. All voted in favor. None voted against. The motion was carried.

# An Ordinance Relating to the Vacation of a Certain Portion of a Street within the City of Canby, Minnesota

The Southeasterly Sixty feet (SE'ly 60') of that portion of Third Street lying between Lot Fourteen (14) in Block Nine (9) of the Original Townsite (now City) of Canby, and Block Forty–five (45) of the Sixth Railroad Addition to the City of Canby, is hereby vacated, expressly subject to the reservation by the City of Canby, its successors and assigns, a perpetual easement for purposes of installing and maintaining water, sewer, storm sewer, telephone, electric, gas, television and other public utility lines, over, under and across said area above vacated.

# **An Ordinance Relating to Nuisances**

The City Council of the City of Canby hereby ordains as follows:

## Section 1 - Declaration of Policy

The City Council of the City of Canby has determined that the health, safety, good order, general welfare and convenience of the public are threatened by certain public nuisances on property within the city limits.

#### Section 2 - Definitions

- A. <u>Deteriorated Structure</u>: Any structure or part of any structure which because of wind, fire or other natural disaster, or physical deterioration is no longer habitable nor useful.
- B. <u>Junk/Rubbish</u>: Any material or substance stored in the open or not enclosed in a building which does not serve, nor is intended to serve any useful purpose for which it was originally

- intended, including but not limited to refuse, debris, used furniture, unused appliances, machinery parts, motor vehicle parts, remnants of wood, metal or any cast off materials.
- 1. <u>Junk Vehicles</u>: A junk vehicle shall include motor vehicle, trailer, semi-trailer or other vehicle as defined in Minnesota Statute 169.01 which is not in operable condition or is abandoned as defined in Minnesota Statute 168B.

Junk vehicles also include any vehicle which is not in street operable condition, or which is partially dismantled, or which is used for sale of parts, or as a source of repair or replacement parts, or which is kept for scrapping, dismantling or salvage of any kind or which is not licensed for operation in the State of Minnesota or other state.

- C. Public Nuisances: The following are hereby defined as public nuisances:
  - 1. Permitting junk vehicles, junk or rubbish, or deteriorated structures to exist or remain on property within the City of Canby, unless housed with a lawfully erected building.
  - 2. Any uncovered well, open cistern or other condition likely to attract children and expose them to danger.
  - 3. Noxious weeds and other uncontrolled growths of vegetation upon public or private property.
  - 4. All trees, hedges, billboards or other obstructions which prevent person from having a clear view of all traffic approaching an intersection.
  - 5. All wires and limbs of trees which are so close to the surface of a sidewalk or street as to constitute a danger to pedestrians or vehicles.
  - 6. Obstruction to the free flow of water in a natural waterway or a public street claim, gutter or ditch.
  - 7. The depositing of garbage or refuse on public lands, public right of way or private property owned by another without the consent of the owner.
  - Accumulations in the open of discarded or disused machinery, household appliances, automobiles, motor vehicles or motor vehicle bodies or parts, garbage, refuse or other material.

#### Section 3 - Provisions

A. No person shall park, keep, place, or store or permit the parking or storage of a junk vehicle, parts, engine or related accessories, on a public street or on any private lands or premises which they own, occupy or control unless it shall be within a building on such premises.

- B. No person shall allow to accumulate, place, or store upon any public or private lands or premises which they own, occupy or, control, any junk or rubbish.
- C. No person shall allow or permit any deteriorated structure or unsafe condition to exist on any private lands or premise which they own, occupy, or control.
- D. No person shall allow or permit any public nuisance as herein defined.
- E. No person shall maintain or permit a condition which reasonably annoys, injures or endangers the safety, health, morals, comfort, or repose of any considerable number of members of the public.
- F. No person shall interfere with, obstruct, or render dangerous for passage, any public highway or right of way, or waters used by the public.

## Section 4 - Penalties

A. Any person convicted of violating any provision of Ordinance 314 is guilty of a misdemeanor and shall be punished by a fine of not to exceed \$1,000.00 or imprisonment for not more than 90 days, or both, plus the cost of prosecution in either case.

#### Section 5 - Exceptions

A. This ordinance shall not apply to any duly licensed junk yard, or to any business duly conducted and maintained in conformity with the City of Canby Zoning Ordinance.

#### Section 6 - Repealer

Ordinances 244B and 244B.1 are hereby repealed in their entirety.
